# COVID-19 in Early 2021: Lies, Inaccurate Tests, the New Strain, and Vaccine Plans

## Jesuit-Educated Dr Fauci Funded Research into COVID-19 Creation

Evidence emerged that some years ago Dr Anthony Fauci, the Jesuit-trained Roman Catholic at the very centre of the world's response to the coronavirus, promoted a highly controversial type of research involving the manipulation of viruses to explore their potential for infecting humans! This was reported by *Newsweek* as far back as April 2020. In 2011 Fauci played an important role in promoting this research. He claimed that it was worth the risk involved. In 2014 over 200 scientists pressured the Obama administration to temporarily halt the funding for this research, because of the risk that a manipulated virus could accidentally escape a lab and start a pandemic.

And where was this research carried out, funded by Fauci's National Institute of Allergy and Infectious Diseases? At the Wuhan Institute of Virology in China – where the virus originated!

Under Fauci's direction this virus engineering *secretly* resumed in 2017 when the US National Institutes of Health lifted the moratorium, and it continued until April 2020.<sup>1</sup>

## Number of Deaths Worldwide by Early January 2021

The man in the street keeps looking at the figures of those infected, instead of focusing on the figures of those who died. The figures of those infected naturally increase continually, but as the vast majority of them recover those figures are not the ones which are really important. How many *died*? That is where the focus should be. And the fact remains that deaths from the virus are a minuscule percentage of the population:

As of early January 2021, over 85 million people worldwide had the virus. This out of a world population approaching 8 billion. And how many of those had actually died? Over 1.84 million. Do the maths: what tiny, tiny percentage, then, of those who had the virus actually died of it?

However, by 2021 it was well known that deaths were being declared to be from COVID, or "COVID-related" (conveniently vague), when they were not. What we know for certain, then, is that the *true* numbers of COVID deaths are *far fewer*, even, than the official numbers given – which are already so extremely low.

## Manipulation of the People

The evidence streamed in from many countries: as the lockdowns persisted, or were dropped only to be reinstated, despair and fear set in. When would this ever end? people wondered. The UK was particularly hard hit by the second lockdown at the end of 2020 and continuing into 2021.

"The Psychological Attack which is being carried out upon the citizens of the UK, is dark, cruel and manipulative," wrote British writer Shirley Edwards. "After weeks of a complete lockdown in society... and with no hope of a release until Spring; a deep sense of despair is affecting many. A huge division, a chasm, and an abyss is being created through extreme fear and isolation.... departing from

the EU now seemed hardly noticeable or relevant under the current climate of the government's total dictatorship...

“Whilst HM Government have been implementing even more frightening tactics by interrupting TV programming with scenes of people on oxygen, silencing free speech and encouraging us through billboards and posters to ‘Act as though we have the Virus’; people who can barely breathe through forced imprisonment and a bombardment of negativity, are desperately in need of some optimism outside of the applied behavioral psychology which I believe is being used against them. Like small tiny sparrows they wait for the odd crumb of Hope...

“Telling people to act as if they are potential murderers is irresponsible, and leads people further into the trap and deadly disease of isolation and hopelessness. We were once free and responsible people, happy to play our part in protecting others. Now we are snitches on our neighbor's [sic], and enemies to our friends and family.”<sup>2</sup> This is very true, and also very deliberate.

## **The Tests Not Accurate: the Illusion of Being in a Pandemic**

In August 2020 the *New York Times* examined PCR testing data in three states, and discovered that “up to 90 percent of people testing positive carried barely any virus” and were not infectious.

Even the Jesuit coronavirus health advisor to the White House, Dr Anthony Fauci, finally admitted that PCR tests picked up harmless fragments of the virus that produced many false-positive cases, and that the result was an over-stating of the actual threat.

A briefing published by four British scientists concluded that PCR testing was “distorting policy and creating the illusion that we are in a serious pandemic when in fact we are not.” Read that again.

And in mid-January 2021 even the World Health Organisation (WHO) officially acknowledged that the “gold standard” test used to diagnose COVID-19 had a high rate of false-positives, making the test unreliable!<sup>3</sup> It recommended a second test to confirm any diagnosis for those who were not showing any symptoms. The PCR tests were *so* unreliable, in fact, that the WHO said health care providers should consider *at least seven other factors* to confirm any test.

## **A New COVID Strain from South Africa**

According to South African epidemiologist, Professor Salim Abdool Salim, and a number of other scientists leading the research studies in South Africa, a new coronavirus strain which emerged in the country in late 2020 and caused the government to institute another lockdown appeared to be more transmissible than earlier variants, and had therefore accelerated the onset of a second wave of infections, *but there was no evidence it was more severe.*

“It's left to be seen whether it will end faster, but certainly it has spread much faster,” he said. “In this study undertaken by colleagues at a London school, they found that the 501Y.V2 variant is 50% more transmissible than the previous variants we have in South Africa.” “The current data indicates that the virus is not causing more severe disease, but it is putting huge pressure on hospitals and we may see in due course an increase that's just from the lack of hospital beds and the pressure on the healthcare system”.<sup>4</sup>

So then: far more people became infected because the new strain was more transmissible, which of course meant that more people died. But the numbers dying were still essentially the same minuscule percentage of those who fell ill.

To illustrate with a hypothetical scenario: if, say, under the first strain 1000 fell ill and 1 in every 1000 died, and then under the new and more infectious strain 10,000 fell ill and 10 in every 10,000 died, obviously more people died than before. The numbers were higher because the infection rate was greater, but the *percentage* of those dying had not changed and the death rate remained very low.

And most of these deaths could have been prevented if, in 2020, they had simply let the first strain of the virus run its course. Without a vaccine there is nothing anyone can do to prevent infections rising: neither masks, nor social distancing, nor any other such measures are effective. It should have been left to run its course. A comparative few would have died, because some people will always die when

a contagious disease is present. This is inevitable. Nothing will stop its spread except either natural or artificial herd immunity.

At Steve Biko Academic Hospital in South Africa, doctors said that a lack of personal protective equipment, overcrowding at the hospital, increased pressure and poor working conditions for doctors meant that more patients were dying than before as the “second wave” spread. Scores of patients, some of whom were COVID positive, were being treated in tents outside the hospital. Those suspected of having COVID were housed in the tents awaiting results, and if they were found to be positive they were referred to Tshwane District Hospital. Some stayed in the tents for days, and many died there.<sup>5</sup>

Is it any wonder, then, that patients were dying in greater numbers? And these deaths could not *all* be attributed to COVID! If a person who was gravely ill from (for example) TB, Aids, or some other disease arrived at hospital for treatment he was put in an overcrowded, understaffed tent with broken equipment, sometimes for days. Many died – *not all* from COVID (remember, it was admitted that only *some* were actually COVID-positive), but from not being properly treated for other illnesses, and also because of the terrible conditions in the tents. One doctor said, “You have to sit and push patients in and out of tents; the oxygen runs out. So now the question is, are our patients dying because of Covid or because we’re just leaving them out in the cold with no oxygen?”<sup>6</sup> Precisely! But these deaths were then attributed to COVID, and even registered as such! Recall Professor Salim’s words quoted above: “The current data indicates that the virus is not causing more severe disease, but it is putting huge pressure on hospitals and we may see in due course an increase that’s just from the lack of hospital beds and the pressure on the healthcare system”.

In the week of 30 December 2020 to 5 January 2021, South Africa apparently had a record 10,907 excess deaths from natural causes. In total, 20,063 people died in that week. This was according to the mortality surveillance report of the Burden of Disease Research Unit at the South African Medical Research Council (SAMRC).

Depending on the methodology used, the SAMRC estimated there were 78,000 or 84,000 excess deaths since 6 May 2020, which was the date when an uptick in excess deaths was first noted. About 55,000 were people over 60 years of age, and about 30,000 were between 1 and 59 years old. The SAMRC declared in its report that “a significant proportion of the current excess mortality being observed in South Africa is likely to be attributable to Covid-19.”<sup>7</sup>

According to the minister of health, by 12 January 34,334 people had died of COVID-19. But this figure was much lower than the SAMRC estimate. Why? The reason given was that many would have died of COVID without being diagnosed, and also that some people with other diseases did not have the same level of care they might have had before COVID, because of the overcrowding of hospitals.

Let us analyse the information given above:

First: to automatically assume that COVID was responsible for a significant proportion of the excess deaths was to assume far too much. Various other causes could have been responsible. SA’s population was also growing every year, so naturally there would be more deaths as well.

Second: the SAMRC said it was “*likely*” that a significant proportion of these excess deaths were the result of COVID. But “*likely*” is not evidence.

Third: people with other diseases did not receive the same level of care as before, which would have meant many more would have died who would not have died in the past, either from those diseases or from COVID because they were already severely weakened from these diseases, and thus susceptible to contracting COVID and dying from it.

Fourth, as stated above, by 2021 it was well known that deaths were being declared to be from COVID, or “COVID-related”, even when they were not.

## **Masks and Their Efficacy**

### ***Masks Do NOT Work - but Mask Regulations Remain in Place***

Back in March 2020 Dr Anthony Fauci said in an interview that in general, “people should not be walking around with masks.” When asked, “You’re sure of it? Because people are listening really closely to this,” he replied: “There’s no reason to be walking around with a mask. When you’re in the middle of an outbreak, wearing a mask might make people feel a bit better and it might even block a droplet, but it’s not providing the perfect protection that people think that it is. And, often, there are unintended consequences – people keep fiddling with the mask and they keep touching their face.”

But it did not take Fauci long to change his tune completely, and to start insisting that the whole world should wear masks!

In October 2020 an analysis of over a dozen graphs charting the number of COVID cases revealed that various studies were correct – wearing a mask had no effect on the spread of the virus.

In November 2020, the first large, randomised controlled trial of its kind, published in the *Annals of Internal Medicine*, revealed that there was no statistically-significant difference in COVID cases between those who wore masks and those who did not.

Sweden’s chief epidemiologist, Anders Tegnell, told *Science* magazine, “The evidence [for the effectiveness of wearing masks] is weak. Countries that have masks are not doing the best right now. It is very dangerous to try to believe that masks are a silver bullet.”

Yet despite the solid evidence available on the ineffectiveness of wearing masks against the virus, governments worldwide continue to insist on it.

In America, soon after Biden was sworn in as president, he signed an order requiring people to wear masks on all federal property. Then an order from the Centers for Disease Control and Prevention (CDC) went into effect, requiring people to wear masks while using public transportation or in transportation hubs. And it gave federal authorities the power to enforce it through criminal penalties. Failure to comply would also result in being prohibited from travelling.

It was correctly pointed out by the libertarian magazine, *Reason*, that creating “a vast network of law enforcement officials empowered to enforce these mask rules will of course provide a handy new excuse for monitoring and surveilling citizens.” And *that*, in a nutshell, is what this is all about. It has nothing to do with supposedly protecting people from a virus –since it doesn’t work and isn’t necessary anyway. It has everything to do with controlling the population.

## **Vaccines and Their Efficacy**

According to a study by Pfizer, its own vaccine had a 95% efficacy. But – “We don’t have the data yet to know whether these vaccines actually prevent people from getting the virus,” said Lisa Lee, a public health expert specialising in infectious disease epidemiology who previously worked at the Centers for Disease Control. “We only know that they prevent people from getting really sick from the virus.”<sup>8</sup>

One of the founders of BioNTech said that as good as a vaccine would be, it would not be perfect: “I’m very confident that transmission between people will be reduced by such a highly effective vaccine – maybe not 90% but maybe 50%”.<sup>9</sup>

Many people were under the impression that once they received the vaccine they would no longer be required to wear masks or practice “social distancing”. But in this they were wrong – the global overlords had no intention of dropping these measures immediately.

## Seeking to Create a COVID-19 “Vaccination Passport”

Red China – where the coronavirus first began – is attempting to use the worldwide fear about the virus to launch a global tracking system. At a virtual G20 leaders’ meeting on 21 November 2020, the Chinese Communist leader, Xi Jinping, called for countries worldwide to accept a global COVID-19 tracking system which uses QR codes. It would provide users with a colour code based on their risk of exposure to the virus, and the QR codes could be read on mobile devices. This use of an electronic barcode would help to determine the “health status” of international air travellers. A green code would indicate that someone was safe to travel, an orange or red code would indicate that the person would need to quarantine for up to two weeks.<sup>10</sup>

“Not everyone is thrilled with a brutal communist dictator, one openly bent on ruling the entire planet, launching a new surveillance and people control system.... Human Rights Watch executive director Kenneth Roth tweeted, ‘Beware of the Chinese government’s proposal for a global QR code system. An initial focus on health could easily become a Trojan Horse for broader political monitoring and exclusion, akin to the dangers associated with China’s social-credit system.’”<sup>11</sup>

And sure enough, a coalition of technology and health organisations – including the giant Microsoft – began working on developing a digital COVID-19 “vaccination passport” to be used by countries and businesses *to enforce mandatory vaccination*. It is called the Vaccination Credential Initiative, and its purpose is to enable people to “demonstrate their health status to safely return to travel, work, school and life while protecting their data privacy”. To achieve this purpose the coalition is working with technology created by The Commons Project, in partnership with the Rockefeller Foundation.<sup>12</sup>

The digital certificate being developed would be stored on a smartphone in a digital wallet or a physical QR code.

### *The United States*

Dr Anthony Fauci said in August 2020 that he would not support mandatory vaccinations, as such a step would be “unenforceable and not appropriate”.<sup>13</sup> However, states, cities and businesses could require vaccination and even impose penalties on those refusing to be vaccinated.

Very clever! It won’t be mandatory on paper – but in practice it will!

In New York by early January 2021, lawmakers were seriously considering a bill that would allow the governor to forcefully “remove” anyone who was deemed to be a “threat” to health, to imprison them and then to vaccinate them without due process. According to a report, “Once some health department worker thinks a New Yorker is a carrier or contact to a carrier, that person could be seized and held without hearing, trial, due process or bond for a period of time to be determined by the health department.” According to the New York assembly website, a person would not even have to be identified by name to be taken into custody: a “reasonably specific description” would be all that would be required. Furthermore, those detained could be held in “isolation.”<sup>14</sup>

Welcome to tyranny. A manufactured virus, and a “pandemic” that isn’t, have enabled leaders to enslave us all – and to do so with the willing compliance of the majority, because they are so afraid of falling ill.

### *South Africa*

Will the vaccines be compulsory in South Africa? No, said South African president, Cyril Ramaphosa. No one would be forced to take the vaccine, nor would anyone be forbidden from travelling anywhere or taking part in any activity if they have not been vaccinated.<sup>15</sup> Ah, but again – if you’re unable to travel, do business, go into shops, etc., unless you’re vaccinated, you *are* in effect being forced to be vaccinated. But the government will be able to say, “We didn’t make it a legal requirement!”

In South Africa – a Communist-dominated state – the vaccine procurement process was mismanaged on a colossal scale, with the health minister giving scant details about the roll-out, and being very vague on the timelines and delivery dates. Why was this?

“Government’s customary incompetence is no doubt partly to blame, but there is more to it than that. Ideology is the decisive factor, along with the ANC’s desire for comprehensive control. Equally important is the opportunity the ruling party now sees to ‘pilot’ the vital ‘single-buyer’ element in the proposed National Health Insurance (NHI) scheme.

“Ideology [*Communist and racist* ideology, be it noted! – *S.W.*] requires that vaccines be sourced – not from the ‘imperialist’ West and its private corporations – but rather from China and Russia and their state-controlled entities...

“Ideology further requires that the entire vaccination procurement and distribution process be controlled by the government...

“Ideology lies also at the root of the government’s refusal to allow the private sector to buy vaccines directly from the pharmaceutical companies whose approved products are already being rolled out in some 30 countries...

“But a centralised government monopoly [i.e. Communist strategy as always – *S.W.*] over vaccine procurement and distribution will put all the country’s eggs in one basket, excluding competition and increasing the risks of failure. It is also likely to prove cumbersome, incompetent, and wide open to corruption”.<sup>16</sup>

In other words, the ruling party in South Africa, the ideology of which is Marxist-Leninist, was using the coronavirus vaccine response to increase its power over the entire country, to control the citizens, and of course to make even more money by dubious and underhanded means for the fat cats in government.

## ***Spain***

This is very sinister.

Spain began compiling a register of every citizen who refused to be vaccinated. And it said it would share the list with other European Union countries. The Spanish minister of health announced in a TV interview on 28 December 2020, “What will be done is a register, which will be shared with our European partners... of those people who have been offered it and have simply rejected it.”<sup>17</sup>

Spain of course, like most of Europe, is Roman Catholic and its governments have always been totalitarian, or leaned towards totalitarianism. It is typical Roman Catholic and Socialist overreach. And it will not be limited to Spain.

Once again: “We won’t make vaccination mandatory. We’ll just keep a register of all those who refuse.” This will frighten almost everyone into being vaccinated. It’s not free choice if they’re holding a gun to your head.

## ***Australia***

In August 2020 Australian prime minister, Scott Morrison, suggested making the vaccine mandatory for all Australians; but he later backtracked on this.<sup>18</sup> However, the CEO of Qantas, the Australian airline, said in December 2020 that proof of vaccination would be required of all international passengers, and added that other airlines would probably follow suit.

Again: it’s not free choice if they’re holding a gun to your head.

## ***And What Does the Pope of Rome Say?***

No surprise at all: Francis I, the Jesuit pope, fully supported the global vaccination plans. “I believe that ethically everyone should take the vaccine,” he said in an interview. “It is an ethical option, because you gamble with your health, your life, but you also gamble the lives of others.” He himself was scheduled to be vaccinated, he added.<sup>19</sup>

Of course, what he said was simply not true. Refusing a vaccine for something which is not dangerous to the overwhelming majority of the human population is *not* gambling with your life or the lives of others. This is nothing but a scare tactic. It is guilt manipulation by telling an outright lie.

## **Should Christians be Vaccinated against COVID?**

This aspect of the entire sordid business needs to be approached with caution and common sense. Hysterical voices are raised by those who have read sensationalist but inaccurate articles on the internet about COVID vaccines.

Let me be clear here: I am absolutely *not* opposed to vaccines *per se*. The medical science behind vaccination is certainly not evil, in fact it is one of the greatest medical breakthroughs in history. Vaccines are *not* the mark of the beast (see my article on this<sup>20</sup>), and they are *not* “contaminated with fetal tissue” (this myth has spread far and wide, but myth it is<sup>21</sup>). It is sad that so many professing Christians fall for these lies.

But the issue here is not whether or not Christians should take *any* vaccines; the question here is, should Christians take the *anti-COVID* vaccines?

And the simple answer is as follows: if it is voluntary, there is no need for the vast majority to take it. Why not? For at least three reasons:

The first reason is (as I have written elsewhere): it is unnecessary for the health of the majority. There is a huge difference between the COVID vaccines and vaccines for such things as smallpox, polio, etc., for the virus is not even remotely dangerous to the vast majority of the world’s population, and most people who contract it either recover without even knowing they had it, or experience only mild symptoms. With other vaccines, there is always a small risk of injury, but the benefits far outweigh the risks. But the COVID vaccines are for a virus that is simply not deadly for 99% of the world’s population.

The second reason is because the pro-COVID-vaccine “experts” tell us that even if people take the vaccine, they will still have to wear masks, maintain “social distancing”, and probably even need to have the vaccine again after some months. Well then, since the vaccines are so utterly useless, why have them at all? It is not necessary to your health at all.

And the third reason not to have the COVID vaccine if you are able to continue with your life without it, is that the long-term health risks have not been properly evaluated, and by the very nature of the case they cannot be, because the vaccines are being produced very rapidly and sufficient time has not elapsed to fully monitor their safety. At the very least, it may be wise to try to delay taking the vaccine for as long as possible.

That said, even though as believers we might be against “vaccine passports” because they are absolutely unnecessary, in addition to the fact that from a safety standpoint we simply do not yet know the long-term effects, the fact remains that if you are unable to work without being vaccinated, or to travel, etc., *you don’t sin by being vaccinated*. As I have written elsewhere:

If mandatory vaccines become a reality, what should the believer do then? As bad as any enforced mass vaccination programme would be, since it would be contrary to liberty and individual choice, and even though one might legitimately disagree with the entire concept of a mandatory vaccine for something which is not life-threatening to the vast majority of the world’s population, one does not sin against God if one is forced to be vaccinated in such a programme. We are to obey the authorities in everything except that which causes us to sin against the Lord. Submitting to a vaccine, no matter how unnecessary it might be, would not be sinning against the Lord.

## **What’s Next on the Horizon?**

Don’t think this COVID business is the first and last time the leaders of the world will do what they have done to the citizens of their countries. Oh no. This is only the beginning. The elites are

preparing us for more.

In South Africa in early February 2021, in the midst of the country's "second wave", Health Minister Zweli Mkhize said South Africa and other African countries should prepare for the impact of a possible "third wave" of infections – and that this could be even more damaging than the previous two. "What we have seen is that in most of the countries the second wave has come to be much heavier, fiercer, and cost more lives. It is also likely that we might face a third wave. There is no way of being able to prevent it. Its impact will probably be more devastating."<sup>22</sup>

We're being primed for further lockdowns. Further people-control measures. Further tyranny and the destruction of freedoms.

In January 2021 Bill Gates warned that the world must prepare for the next "pandemic" as it would prepare for a war. He wrote, "We can't afford to be caught flat-footed again. The threat of the next pandemic will always be hanging over our heads – unless the world takes steps to prevent it."<sup>23</sup> And what did he recommend? Money, and lots of it. "Stopping the next pandemic will require spending tens of billions of dollars per year – a big investment, but remember that the COVID-19 pandemic is estimated to cost the world \$28 trillion," he said. "The world needs to spend billions to save trillions (and prevent millions of deaths)."

What a deceiver this man is! Lie No. 1: men like Gates were not caught flat-footed at all, since they planned this very thing years before it happened, as I have shown elsewhere. Lie No. 2: since COVID-19 was not truly a "threat" to the world, as it affected comparatively very few of the world's population and the recovery rate was excellent, it is incorrect to speak of "the threat of the *next* pandemic". Lie No. 3: saying there is a need to spend billions of dollars.

Prepare for very difficult days ahead, Christian. Go down on your knees, fast and pray. Study the Scriptures. Grow in grace and in the knowledge of the Lord Jesus Christ. Take heed to what you hear. Be not deceived. Be wise.
